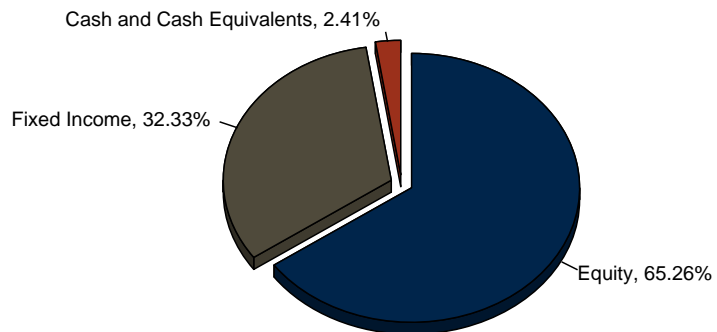

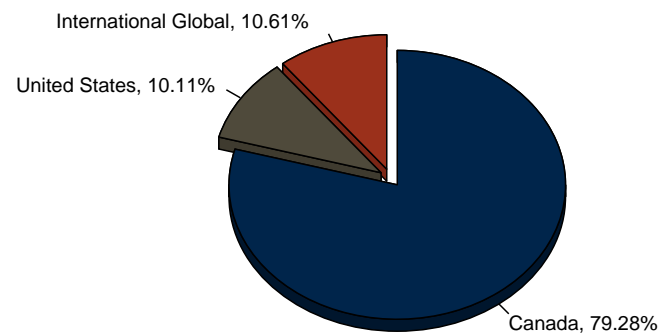

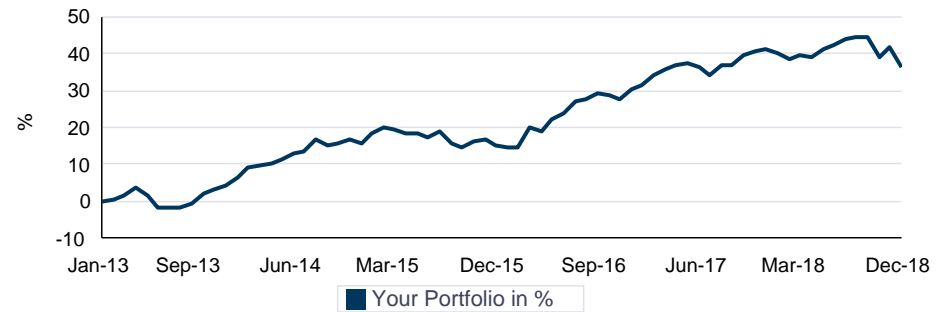

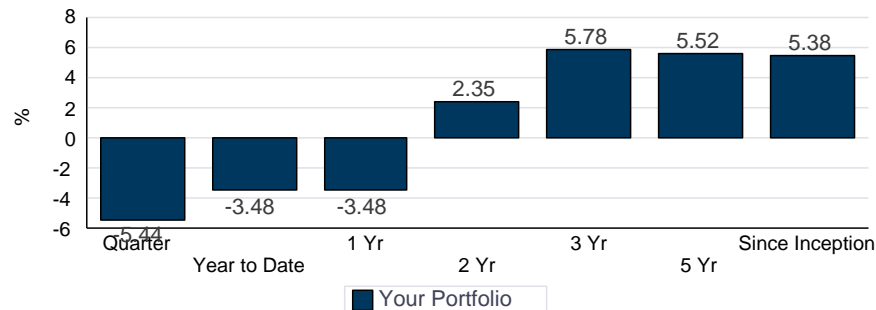

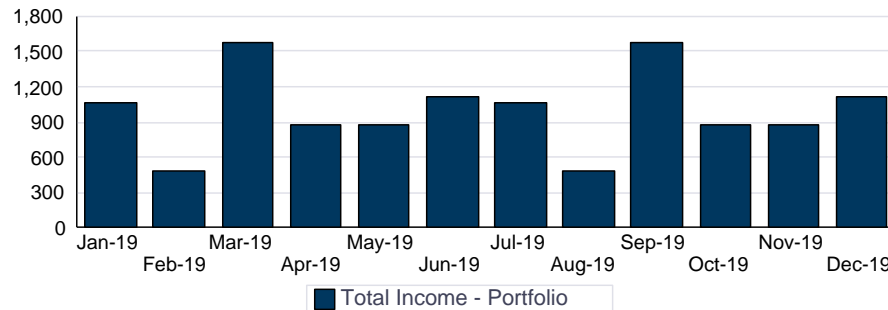

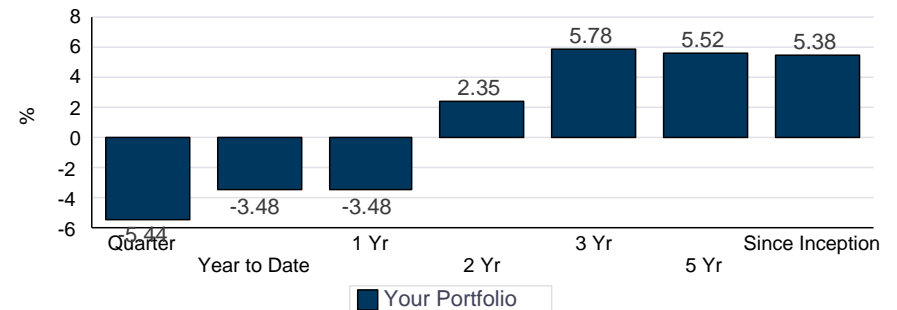

January 24, 2013 To December 31, 2018**

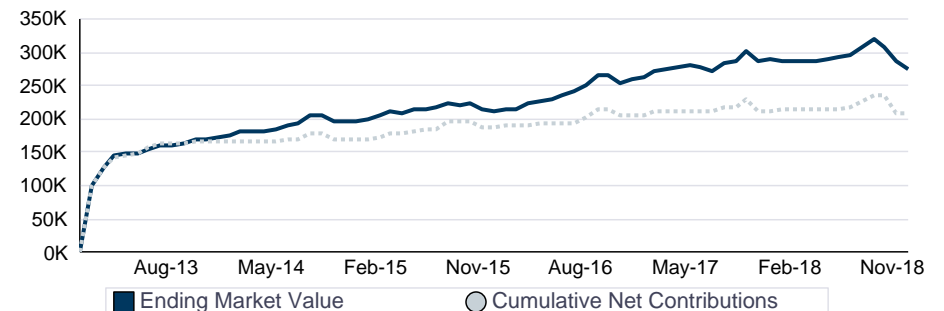

January 24, 2013 To December 31, 2018**



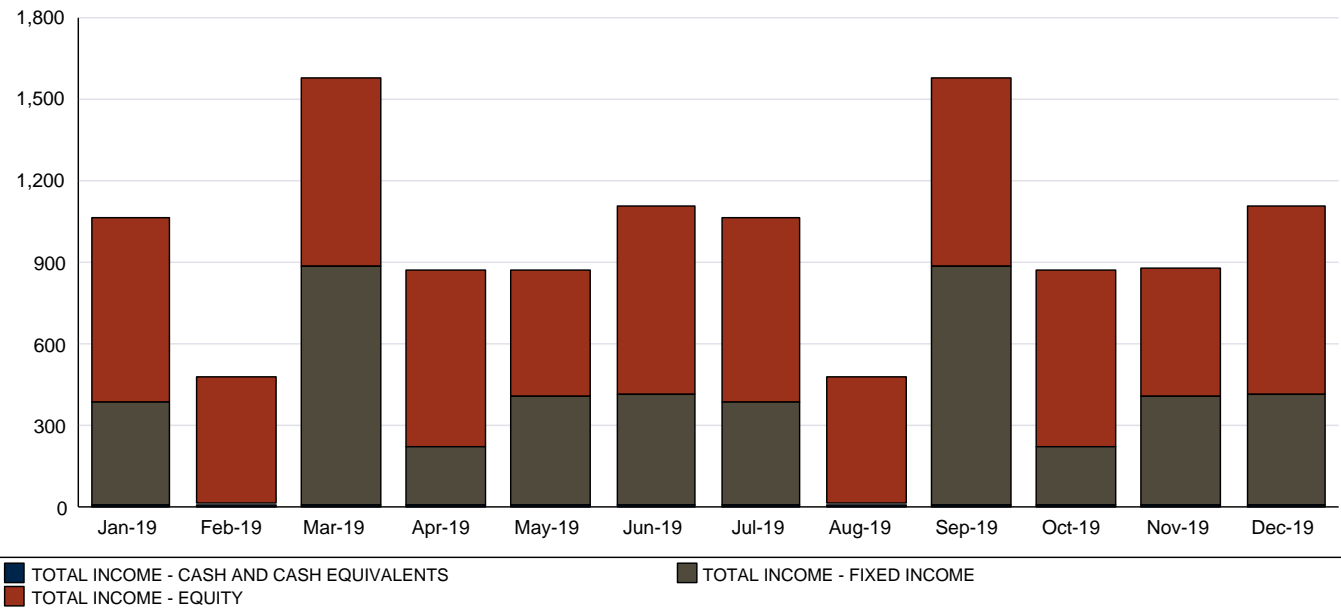
